Competition Rules

- Must be **10 years** of age or older
- Contestants must not touch hotdogs until the start signal
- Must consume entire hotdog for hotdog to be counted. (An entire hotdog includes the bun)
- Contestants will have 5 hot dogs, and will be timed on how fast all hot dogs are consumed.
- Buns and hotdogs may be separated, dunked or mangled.
- Visible signs of sickness will result in disqualification
- Ties will be determined by an "eat off"

The event will consist of a number of contestants behind a table with hotdogs in buns. A glass of water will be provided to each contestant for drinking or dunking. Condiments are allowed but are usually not used. The hotdogs will be cooked and slightly warm. Each contestant will have 5 hotdogs (with buns) to eat, and will be timed. The winner will have eaten the hot dogs in the shortest time (every chew counts). Both hands may be used during the competition. The top 3 (best) times will receive prizes.
